# **Bequests**

Bequests require no more than confirmation from a lawyer to ensure you have the correct language as required by the laws in your state. Bequests allow you to receive a tax-saving deduction from the value of your donated assets. These gifts include wills and living trusts.

# **Beneficiary Designations**

Beneficiary Designations allow you to choose the American Legislative Exchange Council as the beneficiary to your retirement plans, insurance policy, or cash accounts. This option gives you and your family tax benefits without requiring you to change your existing will.

### **Life Income Plans**

**Life Income Plans** allow you to make a gift to the American Legislative Exchange Council and to receive income for your life or for the lives of your selected beneficiaries.

# Planned Giving Gifts can be made with language such as:

"I give and devise to the American Legislative Exchange Council, located in Virginia 22202, the sum of \$ \_\_\_\_\_\_ (or asset) to be used for general support (or for support of a specific fund or program)."

– OR –

"I give and devise to the American Legislative Exchange Council, located in Virginia 22202, all (or a percentage) or the rest, residue, and remainder of my estate, both real and personal, to be used for its general support (or for support of a specific fund or program)."
